Minutes of the 43rd Annual General Meeting of the Woolton Society held at Woolton Village Club, Allerton Road, Woolton on Wednesday 18th November 2015 at 7.30 pm.

Attendance:

The chairman welcomed all present and referred them to the meeting documents published in advance in the Society's newsletter No 336, together with the statement of accounts for the year ended 31 August 205 distributed at the meeting.

- 1. Notice convening the meeting. This was read by the chairman.
- 2. Apologies for absence. Apologies were noted from Jean & Peter Bates, Viv & Alan Hicks, Henry Stott,
- Viv Stern, Hilary Rock-Gormley, Paul King, A Wilkie, L Baldwin, M Chitty and Dorothy Chance.

 3. 42nd AGM minutes. Minutes of the 42nd Annual General Meeting held on 19th November 2014 and distributed in advance to all members were accepted as a true record, on a show of hands.
- 4. The hon. treasurer's report. The hon. treasurer Charles Davies presented the accounts for the year ending 31 August 2015 and commented on some items. The accounts showed a slightly reduced surplus for the year. The accounts approved by the executive committee were accepted on a show of hands.
- 5. Chairman's remarks. In lieu of a personal statement the chairman invited other officers of the committee to give a report for their areas of responsibility.
- The hon, secretary, Paul Wilkie reported that the executive committee met 7 times during the year, no additional members were co-opted, and there were three resignations. In the same period there have been 4 issues of the society's newsletter, ably edited by our chairman Jean Davies. Thanks are due to all involved in production and distribution of the newsletter. Jean Davies also organised another five outstanding talks, attracting very good attendances. This year the society again organised a visit, this time to St James' Gardens to follow up on the excellent talk. This guided tour was both interesting and instructive, and was well received by those attending.

During the year the society has purchased a stand for the video projector, and a freestanding vertical banner for use at talks and other society functions. We continue to regularly take a stall on the Farmer's Market to recruit new members and publicise the work of the society. To aid in publicity for the society, we have purchased an additional quantity of "Woolton Tea Towels", which have sold well at the Farmers Market, attracting a number of people to the stall.

Copies of the reprinted "History of Much Woolton" continue to sell well, both from the Farmer's Market stall and through Brown's newsagents who have supported the society by selling this since its original publication. Through the work of our past vice-chairman Henry Stott and committee member Janet Hollinshead, there has been considerable progress on the "Quarry Book" and it is now hoped to publish this early next year. Once again for Heritage Open Days weekend the society ran walks. One of these walks was based on the "Janet Gnosspelius Woolton Walks" led by Charles Davies and Paul Wilkie, and there were also a number of Beatles walks led by Jean Davies. We also took the opportunity to sell copies of the "History of Much Woolton", and recruit new members, with some success.

During the course of the year members of the committee have been working on cataloguing Janet Gnosspelius's archive. Much of this is now complete, and the material has been lodged with the Liverpool Record Office. This also revealed a number of books by Arthur Ransome which had been mistakenly placed in the archive boxes. These were taken to the Liverpool University Sidney Jones Library to whom they had been bequeathed.

The committee were also invited to meetings with the architects and developers of a number of proposed developments during the year, to give the society's view on their proposals.

- In the absence of the membership secretary, Paul Wilkie reported membership for the period rose to ii) 305, the highest for many years. Of these, 165 received newsletters by email, representing 39% of households. Apart from 16 which are delivered by post, and the remainder are hand delivered.
- The environment secretary, Chris Darnton reported that this year we have seen the ongoing & contentious issue of St Julie's being rebuilt partly on a public park. This now looks, after a long battle, as though it is going ahead.

The two fields of Woolton Woods that front the High Street, still remain on the council's list of potential sites for housing – this is despite several other public parks such as Allerton Towers being removed from the list. We only have to look down the road to Calderstones Park and see that Calder Kids, Beechley Stables and the miniature railways are to be sold off and developed for housing. Woolton Library has been sold to a developer although no planning application has been made. The former farriers on Quarry Street, Watergate Lane site and the orchard on Church Road South are now currently under development after being razed to the ground. There are issues with the grade 1 listed Woolton Hall deteriorating, as seen by members on the heritage walk in September, with water coming into the building in multiple locations. The council officers who inspected it at my request have stated they couldn't see much wrong with it – however they did go during a prolonged dry period. After contacting the Liverpool Echo "Stop the Rot" campaign they did not want to get involved with another building as they are concentrating on the buildings they have already discussed in their publication. I contacted Historic England to ask could Woolton Hall be put on their "at risk" register. They said they are now in touch with council officers about arranging a visit which is encouraging

The Woolton Society has been informed that the owners of Woolton Hall turned down a £2.5M offer for Woolton Hall by a developer who wanted to refurbish the hall for the use of high end weddings along with accommodation for guests. This would have been done with the assistance of Heritage Lottery Fund grants so would have had to comply with conditions of keeping the integrity of the Grade I asset. Some of our committee members saw the plans, spoke to the developer and liked what we saw. It seems a shame that the owners were not able to come to some sort of deal.

The Woolton Society is effectively one voice in these planning matters. If residents and people who value our assets and open public spaces and are not happy with the way things are developing then they must take ACTION themselves. People need to object to planning applications, take the elected councillors to task as well as council officers responsible for protecting conservation areas and other public assets.

It has been encouraging to see the new businesses in the village continuing to thrive. The addition of outdoor seating at Coast and The Istanbul restaurant gave the village a continental feel over the summer.

6. Election of officers.

Chairman: The current chairman Jean Davies offered her resignation from the committee and was nominated for the position of chairman, and duly re- elected.

Paul Wilkie was willing to continue as vice-chairman, and was nominated and duly re-elected to the post. In the absence of nominations for the role of hon. secretary, Paul Wilkie volunteered to continue in this role, until a candidate could be found and was duly elected.

Hon. Treasurer: Charles Davies was willing to continue and was duly re-elected.

Membership Secretary: The current incumbent, Jean Bates was willing to continue and was duly re-elected. Environment Secretary: The current incumbent Chris Darnton was willing to continue and was duly re-elected. Les Baldwin resigned from the committee, this making the fourth resignation required under the constitution. Bernard Krasner and Thomas Tewskesbury stood for election to the committee.

All the above were proposed, seconded and, there being no other nominations, were duly elected.

7. Any other business.

7.1 Constitution

Paul Wilkie presented the proposed changes to the constitution, pointing out it was nearly 40 years old, and also mentioning that due to the technology of the day, there were multiple slightly different versions in circulation, with no definitive copy. Each of the changes was presented individually, and after some discussion the meeting concluded that further work was necessary on redefining the boundary of the area of interest. David Massey also pointed out that it might be necessary to get permission from the Charities Commission to change the area of interest.

The revised constitution without the boundary changes was accepted on a unanimous show of hands.

7.2 Thanks

Thanks were also offered to those organisations which support the Society; the Village Club for the rooms for the talks and committee meetings, Riverside Screenprints Ltd. who have housed Janet Gnosspelius's archive for the society, and our accountants HBD Accountancy Services LLP.

The chairman thanked everyone for their attendance and closed the formal part of the meeting at 8.40 pm, when the appropriate officers signed the society's accounts.

Alan Gaskin, Woolton Society's first chairman

We have been notified of the death of the Woolton Society's first chairman, Alan Gaskin, earlier this year, aged 93. Alan was a founder member of the society in 1972, & chairman for several years with co-founder Janet Gnosspelius as secretary.

Alan was born in Liverpool, & educated at Liverpool College. He volunteered in 1941 & served in North Africa & Palestine with the King's Dragoon Guards Regiment, Tank Division. On his return he worked for Princes Foods, becoming Managing Director. He retired to North Wales, but returned to Woolton in 2009, living at Reynolds Court on Vale Road. He continued to take an active interest in the society until his death in April this year.

Alan leaves a son & daughter, & four grandchildren. He will always be remembered as a founding father of the Woolton Society.

Talk of 21st September

Elaine Middleton of Age Concern Liverpool and Sefton gave a very well received talk on this date, the first of the Autumn season. Mrs Middleton spoke of the many & varied aspects of the work undertaken by Age Concern, such as assistance with writing wills, & the day centres run by the charity. Environment News

The Draft Liverpool Local Plan

The council has unveiled its 15 year plan for the city& is inviting comments from residents. Described as a "roadmap" for the city's future, the council has in this document outlined its priorities. Key points are the protection of the city's parks; using brownfield sites for building; controls on student accommodation & fast food outlets, helping shops & services within district & local shopping centres. The plan can be viewed at the Municipal Buildings on Dale Street, at the Central Library on William Brown Street, & at all community libraries in the city.

Glenacres Public Right of Way update

The City Council's Highways department anticipated making a decision on the PRoW claim by early September, but as yet we have heard nothing. Assuming the claim is accepted then a Definitive Map Modification Order will have to be drafted & publicly advertised. Interested individuals & organisations will then have six weeks to make representations to the council, either in support of the order or objecting to it .The WS will keep members informed of all progress.

Strawberry Field consultation meeting

The Salvation Army's Strawberry Field Project Team held a consultation evening on September 21st to outline their plans for the Beaconsfield Road site to residents. The plan is to move the sandstone wall to create a layby for vehicles, & demolish the 1960s buildings. The Salvation Army intends to build a centre for vulnerable young adults at the site, & provide a visitor centre & café.

The WS approves of the plans, which show concern for the grounds & parkland, & the layby will improve the traffic flow at this very congested location.

Traffic congestion in the village

The WS has recently approached all three local councillors about the congestion in the village, & car parking problems. All the councillors are concerned about the current situation, where there is gridlock on Church Road at 3.30 every school day, & cars parked thoughtlessly in the village at all hours without fear of sanction by traffic wardens. The councillors have promised a consultation meeting with residents, where views can be exchanged & solutions sought. We will notify members when this meeting is planned.
