Minutes of the 47th Annual General Meeting of the Woolton Society held at St Mary's Church hall, Woolton on Wednesday 20th November 2019 at 7.30 pm.

The chairman welcomed all present and referred them to the meeting documents published in advance in the Society's newsletter No 352, together with the statement of accounts for the year ended 31 August 2019 distributed at the meeting.

- 1. Notice convening the meeting. This was read by the chairman.
- 2. Apologies for absence. Apologies were noted from Donna Jackson, Janet Hollinshead, Jean Bates, Allan Hicks, Linda Parsons, Janet Collins, Christine Vane, Ken Pye, Bernard Krasner, John Ashton, Barbara Doherty, Liz & Andrew Spencer, Carl & Pamela Baker, Carol and Andrew Zsigmond
- 3. Minutes of the 46th Annual General Meeting held on 21st November 2018 and distributed in advance to all members were proposed as read by Jean Davies and accepted as a true record, on a show of hands.

4. Chairman's remarks.

The chairman commented on some of the areas the society had been involved in, particularly the commissioning of blue plaques to highlight places of interest in our area. The first 3 of these are now in place, with the plaque marking the home of Inspector Menzies being formally unveiled by the Chief Constable last weekend. The committee are now considering sites for further plaques – any suggestions by email please. She invited other officers of the committee to give a report for their areas of responsibility.

- i) The hon treasurer Charles Davies presented the accounts for the year ending 31 August 2019 and commented on some items. The accounts were accepted on a show of hands.
- ii) The hon. secretary, Paul Wilkie reported that the executive committee met 5 times during the year, 3 additional members were co-opted (Bob Collins, Rob Kirby and Mike Cullen), and there two resignations (Bernard Krasner and Donna Jackson). In the same period there have been 4 issues of the society's newsletter, ably edited by our chairman Jean Davies. Thanks are due to all involved in production and distribution of the newsletter. Viv Hicks organised another four evening and two afternoon talks, attracting very good attendances. Following the success of last year's innovations, the society has made the social event for members in the form of a quiz, and daytime meetings part of the regular schedule. All meetings were held this year at St Mary's Church Hall, and this venue has proved popular, as well as accommodating the large numbers we have had at recent meetings. This year the society again organised an outing, this time a visit to the Liverpool Medical Institution, followed by a tour of the Hope Street/ Rodney Street area led by member and blue badge guide Marie Passey. These were again very well received by those able to attend.

A point was raised from the floor that we should not overlook the activity manning a stall at the farmers' market, which does much to increase the visibility of the society.

iii) Environment Secretary Janet Hudson gave a detailed report, commenting on the issues surrounding Woolton Hall, Byron Court, Rushton Properties, Strawberry Field, Knolle Park, the lodge on Hillfoot Road, & the land at Allerton Priory.

This has been abbreviated for reasons of space, with the full report in issue 356 of the newsletter, dated Autumn 2020, copies of which will be available at the AGM.

iv) Membership secretary Jean Bates reported that at the 2018/19 year end on 30th September we had 293 paid up members. For the past 5 years the end of year membership number has been steady, hovering around the 300 mark.

5. Election of new committee members.

Alan Grant indicated he was willing to stand, and being proposed by Viv Hicks and seconded by Rob Kirby, was unanimously elected.

6. Election of officers.

Chairman: The current chairman Jean Davies offered her resignation from the committee and was nominated for the position of chairman, and duly re- elected.

Paul Wilkie offered his resignation from the committee, but stated he was willing to continue as vice-chairman, and was nominated and duly re-elected to the post.

In the absence of nominations for the role of hon. secretary, Paul Wilkie volunteered to continue in this role, until a candidate could be found and was duly elected.

Hon. treasurer: Charles Davies offered his resignation from the committee, but stated he was willing to continue and was duly re-elected.

Membership secretary: The current incumbent, Jean Bates offered her resignation from the committee, but stated she was willing to continue and was duly re-elected.

Environment secretary: The current incumbent Janet Hudson offered her resignation from the committee, but stated she was willing to continue and was duly re-elected.

All the above were proposed, seconded and, there being no other nominations, were duly elected. The resignations from the officers met the requirements of the constitution for resignations.

7. Any other business.

The chairman thanked HBD Accountants for the help they had provided to the society, and everyone for their attendance and closed the formal part of the meeting at 8:45 pm, when the appropriate officers signed the society's accounts.

Society News

Talks programme, 2021

The year has been an eventful one, with the Woolton Society conducting talks via Zoom since February. This has been very successful, both in terms of excellent speakers & audience numbers, but it had always been the aim to return to meeting in person by the Autumn. Unfortunately, because of a combination of circumstances beyond our control, this was not possible, & the committee took the decision, very reluctantly, to cancel the talk planned for September 15th & postpone the start of the new season until the talk in October. This will be an afternoon talk, & all necessary precautions will by then be in place, with members & attendees notified well in advance. **Please note the following guidelines, which have been agreed with the church authorities:**

Using St Mary's hall to ensure the health & welfare of all attendees

- 1. Please do not attend talks if feeling unwell, or with a temperature or cough.
- 2. The hall will be well ventilated, with chairs widely spaced.

Markets & merchandise

The society takes a stall at the local market as it is an excellent source of information for members as well as a chance to meet committee members & browse the publications & merchandise.

The new tea towel, designed by WS member Jenny Brown, has been very successful, with a new order placed to ensure stocks for Christmas. Priced at £6, it shows views of Woolton, & is also available at Brown's on Woolton Street (428 2408).

There are now two books & seven pamphlets published by the Woolton Society: the definitive *History of Much Woolton* (£3), & *Woolton Stone & Liverpool Cathedral* (£5), both available at Brown's.

The pamphlets are: 1. Who Lived at Woolton Hall? 2. Who was Lord Woolton? 3. Hillfoot Villa.

4. Woolton Walks 5. Woolton's Convalescent Home 6. Medical Matters 7. The Nuns of Woolton. All pamphlets are priced at £1.

Matters arising from newsletter 359 & planning news

There is little to report on several Woolton Society projects, as a combination of the pandemic & the unusual circumstances surrounding the council mean that applications are in limbo. There has been no word on the listed buildings consent needed for the plaques project to proceed, & also no word on the permission needed to plant a tree for the society's 50th anniversary next year. The society has been contacted by the Woolton Educational & Recreational Trust which awarded nearly £500 for the plaques project in early 2020. It is hoped that the deadline for spending the grant will be extended.

Woolton Hall is still standing, with the owners, despite ignoring all communications from councillors, planning officers, the Woolton Society & residents, & shuttering up the hall for fifteen years, are now, in a recent article in The Echo, blaming the council for planning delays in a bravura display of chutzpah.

The appeal for Woolton Cinema raised over £20,000 last year, which was given to the owners but the cinema is still closed. Local councillor Kris Brown has been very active in contacting the owners & appealing for action but the cinema, the oldest independent in the city with a plaque dated 1926, remains dark.

Planning enforcement has been contacted by the society, commenting on the unsightly scaffolding on top of 12 &14 Woolton Street which supports three GPS telecom antennae. The structure has a negative visual impact on the conservation area being visually incongruous as well as a potential danger for pedestrians & traffic. There has been no response from planning enforcement.

Planning applications **21H/2245** & **21H/2248** concerning Reynolds Lodge on Church Road have been received very recently. Proposals include a 2 storey extension, new vehicular access to Church Road & internal alterations including a basement conversion.

After many delays a new Woolton Society banner was ordered, this time from a company in West Derby which arrived within a few days & has been in use since August.

Readers will be interested to learn that committee member Rob Kirby will be giving his talk on the Dam Busters raid of May 1943 to the Gateacre Society in November. His talk to the Woolton Society was on Zoom, which some members cannot access. Details are on page 6 of this issue.
